RULES AND ELIGIBILITY

ELIGIBILITY • The Mississippi Children’s Museum (MCM) Lights, Camera, Imagination Talent Search (“Contest”) is open to all legal residents of the United States and District of Columbia, ages 10 and younger. MCM reserves the right to verify the eligibility qualifications of any participant at any time throughout the duration of the Contest. These Contest Rules are governed by all applicable laws.

HOW TO ENTER • Any eligible person wishing to enter the Contest may sign up at the Mississippi Children’s Museum on the audition date to be entered. There is a \$10 registration fee that is required to register. By registering, you accept and agree to be bound by these Official Rules, including the decisions of the Judges, which are final and binding in all respects.

JUDGING • The winners will be selected after completing all appropriate registration documents and participating in the Contest. Judges will screen all participants during the event. A decision will be made within three-four weeks after the initial screening. All winners will be notified by MCM. Please DO NOT contact the museum for results. Winners of the competition will be posted on the MCM website. A panel of judges will select the winners, and their decisions are final. All score cards will remain confidential and participants will not receive any official feedback from the judges.

RULES • All registration forms must be completed prior to the audition. The forms include: Signed Copy of Rules and Eligibility, Signed Talent Release Form, and Contact Information Sheet. Contest participants and/or their parents and/or guardians should not contact the museum for results. All winners will be contacted directly and announced on the MCM Website.

PARTICIPATION • All winners will have the opportunity to participate in multiple photo-shoots that will be featured in MCM marketing material. There is NO guarantee of how many times or specifically where photos will be used. The winners, or his/her parent/legal guardian, will be notified via email and/or phone call that he/she has won and winners will be posted on the MCM website. Participant and his/her parent/legal guardian acknowledge and agree that as a condition of being chosen, ALL winners must reply within seven (7) days following attempted notification.

TERMS OF USE • By participating in the audition, Participant hereby agrees to comply with the terms and conditions stated herein and irrevocably grants MCM, royalty-free, non-exclusive, unconditional, perpetual and transferable license and right to reproduce, encode, store, modify, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and otherwise use or reuse, the Participant’s Audition Photo/Video in whole or in part, as well as Participant’s name and Participant’s image, voice and likeness as contained in the Audition Photo/Video, throughout the universe, in any and all media, now known or hereafter devised, alone or as part of other material of any kind or nature. Without limiting the foregoing, MCM shall have the right to use and change the Audition Photo/Video in any manner that MCM may determine. Additionally, Participant irrevocably grants to MCM the license to send and distribute the Audition Photo/Video via email or instant messenger. Participant irrevocably grants to MCM and its affiliates, legal representatives, assigns, agents and licensees, the worldwide, royalty-free, non-exclusive, sub licensable, unconditional, perpetual and transferable right and license to use the Photo/Video for advertising, promotional or commercial purposes, including without limitation, the right to publicly display, perform, reproduce and distribute the Photo/Video Audition in any media format or medium and through any media channels. Participant forever waives any rights of privacy, intellectual property rights and any other legal or moral rights that may preclude MCM’s use of Participant’s Audition Photo/Video or require Participant’s permission for MCM to use the Audition Photo/Video for promotional purposes and agrees to never sue or assert any claim against MCM’s use of the Photo/Video Audition.

PRIVACY POLICY • All Participants will be required to submit the name & e-mail address of his or her parent/legal guardian when auditioning. All minor’s personal information collected by MCM in connection with the Contest shall be securely maintained by MCM and used only for the purpose of conducting the Contest.
